Region Chair encouraged C.A.R. Directors to update their profiles on the C.A.R website in preparation for the 2019 Committee Appointment selection process.

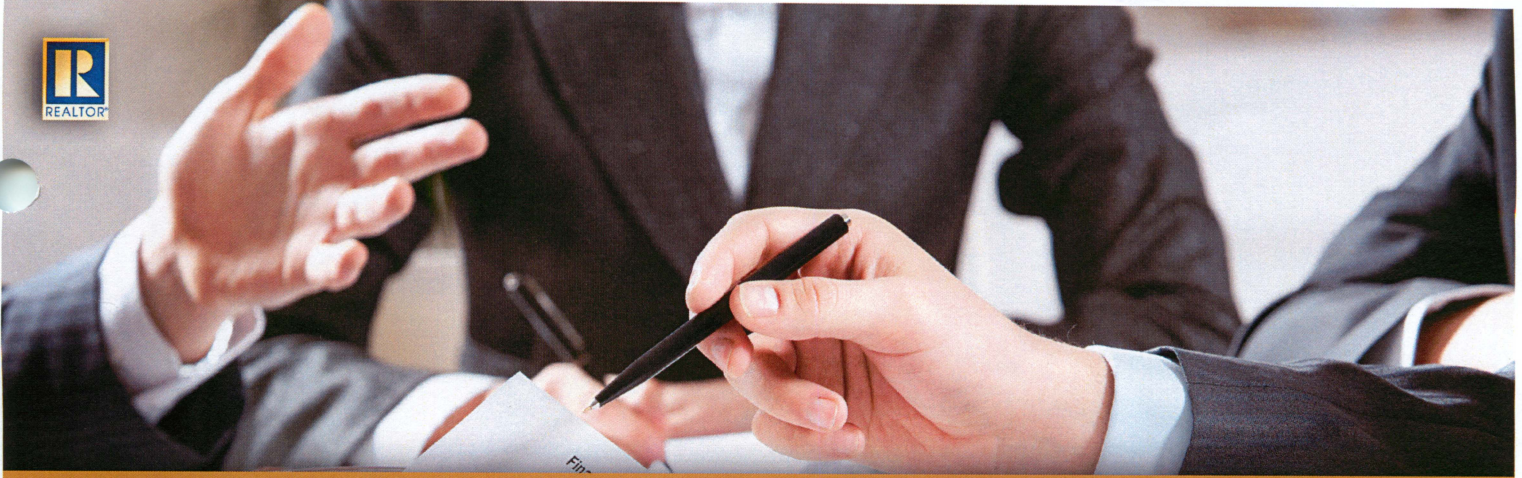
No other business brought before the body for discussion or consideration, the meeting adjourned to Thursday, January 18, 2018 session at 4:30 p. m.
